Personal Background

Born to an unwed teenage mother in the Cabrini-Green housing projects in Chicago, never knowing his father, and adopted by his grandmother at birth, La Shawn K. Ford started his life with few material advantages. When he was two, Ford's family moved into a two-flat family building at LeClaire and Chicago Avenues in the Austin community on the West Side of Chicago. Through hard work, love, and tenacity, his family provided him a chance to attend the school across the street, Our Lady Help of Christians Catholic Elementary School. They overcame further challenges when a fire gutted the family home when he was seven, causing Ford and other family members to live with relatives for some time on the South Side of Chicago in the Englewood community. Ford learned the value of hard work and made money for his family by shoveling snow, mowing lawns, collecting bottles and cans for recycling, and stocking produce in the local grocery store. Because of his drive to help people even at an early age, Ford was called "The Alderman" in the neighborhood. Incorporating the values taught by his church and school, and being a good student, Ford enrolled in another Catholic school, Weber High School. After high school, Ford became the first in his family to attend a four year college when he entered Niles College Seminary, and he contemplated becoming a priest. After a year, he entered Loyola University, where he played on the basketball team and earned a Bachelor of Science in Education with a minor in Political Science. For six years, Ford taught social studies to elementary school students and coached basketball in the Chicago Public Schools, and also worked as a Precinct Captain in the neighborhood where he grew up. As a licensed Real Estate Broker, he then decided to pursue his goal of opening his own business in real estate, and he achieved that goal by becoming the founder and owner of Ford Desired Real Estate, providing services to hundreds of clients since 2001. He is also an Illinois Licensed Insurance Agent and continues to be licensed as a teacher. He lives in the Austin community where he grew up and is the proud father of his daughter, Tia.

Political History and Philosophy

In 2006, campaigning on the theme, "Building Bridges to Success," Ford gained the opportunity to represent the people of the Eighth District in the Illinois House of Representatives. He was re-elected in 2008, 2010, 2012, 2014 and 2016. He was also elected to be a delegate to the 2012 and 2016 Democratic National Conventions. Representing a diverse district, which includes the West Side of Chicago and the suburbs of Oak Park, Berwyn, North Riverside, Forest Park, Proviso Township, Brookfield, La Grange Park, La Grange and Western Springs, Ford has seized the opportunity to work hard on issues important to his constituents and to all citizens of Illinois. Ford discusses issues with his constituents through his radio show on WVON 1690, "The Voice of the People", his cable TV show on CAN-TV Channel 21, town hall meetings, small group discussions in constituent homes, and other opportunities. Town Hall meetings have included: early childhood education; improving education in the Eighth District; the Eisenhower Expressway expansion and job opportunities through the Illinois Department of Transportation; legislation allowing the concealed carry of handguns; whether there should be an elected Chicago School Board; his bill proposing the decriminalization of small amounts of marijuana; issues particular to senior citizens; public safety issues; utilities; unemployment issues for youth, seniors, minorities, and disabled; support for small businesses; support for veterans; information about adoption and foster care; decreasing the use of menthol cigarettes (with Chicago Department of Public Health); decreasing violence; and the heroin epidemic. He has collaborated with community organizations to spearhead the innovative Parents Political University to stimulate grassroots interest and action in suggesting activities and legislation that will help community residents.

Increasing social justice and addressing disparities are the common themes in his work, in areas such as jobs, education, health, increasing opportunities for ex-offenders, small business development, housing and veteran's affairs, and in the 96th General Assembly Ford authored and passed House Resolution 468 with bipartisan sponsorship urging that social justice be the guiding principle in decision-making in the House of Representatives. Ford takes seriously his vow to uphold the Constitution of the State of Illinois, which was established to "eliminate poverty and inequality; assure legal, social and economic justice; [and] provide opportunity for the fullest development of the individual."

EXPANDING OPPORTUNITIES FOR JOBS

- Introduced legislation that was signed into law creating the African American Employment Plan Act to: (1) improve the delivery of State services to Illinois' African Americans; (2) increase the number of African Americans who are employed throughout State government and who are promoted; (3) assist State agencies in meeting goals established by the

- African American Employment Plan; and (4) establish an African American Employment Plan Advisory Council (Public Act 096-1341)
- Introduced the State Employment Application Act (Ban the Box) stipulating that an application for state employment may not ask if the applicant had been convicted of a non-violent criminal offense; introduced in the 95th GA, passed bill through House and Senate, vetoed by the governor in 2007, veto not overridden; similar legislation introduced in the 96th, 97th and 98th General Assemblies; governor issued Administrative Order in May 2013 accomplishing the intent of the legislation.
 - Introduced legislation that became law which gives returning citizens/ex-offenders the opportunity to seal criminal records for certain Class 3 and 4 non-violent offenses to expand job opportunities (Public Act 98-0142)
 - Chaired hearing on Criminal Records Sealing Bill HB5723 and Ban the Box HB1210, August 2012
 - Introduced legislation (HB4954 in the 99th GA) that provides that records of charges that result in an acquittal or dismissal with prejudice, except for minor traffic offenses, may be immediately sealed after the final disposition of the case; lost in the House.
 - Introduced legislation that became law which creates the Commission on Young Adult Employment Act which shall identify issues concerning the readiness and ability of young adults to find employment after completing their education (Public Act 99-0338)

 - Chaired SBE-WD Committee Meetings on Job Creation – July 2011 – more than 500 attended

IMPROVING HEALTH

A Leader in Legislation Related to HIV/AIDS

- Introduced landmark legislation in two different General Assemblies, both becoming law, which makes it easier and less intrusive for patients to be routinely tested for HIV in health care settings while preserving the rights of those being tested (Public Act 095-0007 in the 95th General Assembly and updated as Public Act 99-0054 in the 99th General Assembly)
- Introduced legislation that became law to update state statutes so the most up to date supplemental testing is done to confirm a preliminary positive HIV test (Public Act 097-0244)

A Leader in Improving Nutrition and Exercise

- Introduced legislation that became law establishing the Farmers' Market Technology Improvement Program Act, which helps people use their LINK cards (Food Stamps) at Farmers' Markets (Public Act 096-1088)
- Chief House Sponsor for successful legislation that amends the Local Food, Farms and Jobs Act to establish an electronic database to facilitate the purchase of fresh produce and food products by schools (Public Act 096-1095)

Fighting for a Comprehensive Public High School in Austin

- Introduced and passed a House Resolution which urges the Inspector General of the City of Chicago to conduct a performance audit of the Chicago Police Department to determine and assess police emergency response times in Chicago neighborhoods and communities and to make recommendations to improve response times in primarily African American and Hispanic neighborhoods and communities (House Resolution 569, 99th GA)

(Public Act 100-0304)
- Chief House Sponsor for SB 2433, 100th GA, which amends the Currency Exchange Act, so that determination of rate schedules that can be charged for check cashing and writing of money orders by community currency exchanges takes into account the impact on consumers and whether the rate schedule will disproportionately impact anyone on the basis of any protected characteristic or category listed and defined in specified provisions of the Illinois Human Rights Act, pending

ADVANCING CITIZENSHIP, SOCIAL JUSTICE AND RESTORATIVE JUSTICE

A Leader in Issued affecting Returning Citizens/Ex-Offenders

- Introduced the State Employment Application Act (Ban the Box) stipulating that an application for state employment may not ask if the applicant had been convicted of a non-violent criminal offense; introduced in the 95th GA, passed bill through House and Senate, vetoed by the governor in 2007, veto not overridden; similar legislation introduced in the 96th, 97th and 98th General Assemblies; governor signed Administrative Order on October 3, 2013 accomplishing the intent of the legislation.
- Introduced legislation that became law which gives returning citizens/ex-offenders the opportunity to seal criminal records for certain Class 3 and 4 non-violent offenses to expand job opportunities (Public Act 98-0142)
- Introduced legislation that became law that provides that records of charges that result in an acquittal or dismissal with prejudice, except for minor traffic offenses, may be immediately sealed after the final disposition of the case. (Public Act 100-0282)
- Introduced legislation that became law which limits bail bond costs to \$100 (in Chicago) when the accused is cleared of a crime or if charges are dropped, rather than the previously required 10% (Public Act 99-0412)
- Introduced and passed legislation (HB3920, 100th GA) which provides that a person who drives while his or her driver's license is suspended shall

receive a Uniform Traffic Citation from the law enforcement officer, and that a person who receives 3 or more Uniform Traffic Citations without paying any fees associated with the citations shall be guilty of a Class A misdemeanor, sent to the governor

- Chief House Sponsor of legislation which provides educational grants at public community colleges or universities to persons who are exonerated of their charged crimes (Public Act 99-0199)
- Introduced and passed a House Resolution urging the Governor and the Department of Corrections to discourage prosecutors from recommending and judges from sentencing low level drug offenders to the county jail or the Department of Corrections (HR163, 99th GA and HR5, 100th GA)
- Introduced legislation suspending child support payments for those who are incarcerated, lost in the House (HB2330, 98th GA)
- Introduced legislation to delete the provision that the period of probation for a minor who is found to be guilty for an offense which is a forcible felony, other than first degree murder or a Class X felony, shall be at least 5 years (HB 3224, 98th GA) – lost in the House
- Introduced legislation so a person's obligation to pay child support pursuant to a court or administrative order is suspended by operation of law during any period that the person is committed to the custody of the Department of Corrections or the Department of Juvenile Justice (HB 2330, 98th GA) – lost in the House
- Chaired hearings in August 2012 and April 2013 and Town Hall Meeting in March 2013 on Criminal Records Sealing Bill HB5723 and Ban the Box HB1210, both which have become law
- Organized and hosted A Second Chance Summit at UIC Forum in September 2013 attended by hundreds interested in learning how to seal their records according to Public Act 98-0142
- Introduced and passed House Resolution 361, 100th GA, which designates July 3, 2017 and July 3, 2018 as Illinois Citizens Re-entry Day, to be observed in recognition of Congressman Danny K. Davis' work in helping to provide ex-offenders with a second chance and opportunity to re-enter society as productive citizens, and to encourage continuing support of such citizens as they re-enter their communities

- Introduced and passed a House Resolution that directs the Illinois Juvenile Justice Commission review the current practice of restorative justice in juvenile justice systems in Illinois (House Resolution 396, 99th GA)
- Introduced and passed a House Resolution that requests President Obama to commission a study regarding the economic and social costs of slavery and a proposal for reparations to the descendants of slaves in America if such a proposal is recommended in the study itself. (House Resolution 1011, 99th GA)
- Introduced and passed House Resolution 45 (100th GA) that requests President Trump to commission a study to detail the economic impact of the slave trade and the use of slave labor; and how Emancipation, while freeing them of their literal bonds, and ending an immoral practice, did not guarantee equality in education, employment, housing, and access to quality affordable health care; that this study also include an analysis for how reparations for past harms have benefited the ethnic groups that have received them during the course of American history; and a proposal for reparations to the descendants of slaves in America, and how those reparations can help overcome obstacles that still exist today in education, employment, housing, health care, and justice.
- Introduced legislation and passed by House and Senate (HB4743, 100th GA) that provides that no employer may discriminate between employees by paying wages to an African-American employee at a rate less than the rate at which the employer pays wages to another employee who is not African-American for the same or substantially similar work on a job that

requires equal skill, effort, and responsibility and is performed under similar working conditions (sent to the Governor)

- Introduced legislation (HB4087, 100th GA) that creates the Abolition of Confederate Symbols Act and provides that no public body shall display the Battle Flag of the Confederacy, otherwise known as the "Confederate Flag", or any other similar image, on any public property or land in the State unless the flag or an image thereof appears in a book, digital medium, or museum, or is used to serve any other educational or historical purpose.

A Leader in Civic Issues – Protecting our Right to Vote

- Introduced a House Resolution which urges Congress to amend the Voting Rights Act of 1965 to make all its provisions permanent, adopted by the House (HR0909, 93rd General Assembly)
- Introduced a House Joint Resolution which supports amending the United States Constitution to explicitly guarantee an individual's right to vote, adopted by the House (HJR 0076, 99th General Assembly)

- Introduced the Prisoner Census Adjustment Act in the 97th GA and again in the 98th GA (HB 62) proposing that for purposes of creating election districts and redistricting, requires that State and local governmental bodies use census figures adjusted to reflect the pre-incarceration addresses of persons imprisoned in State or federal facilities in Illinois; passed the House, to be reintroduced
- Introduced a House Bill which creates the No Representation Without Population Act, directing the Illinois Department of Corrections to collect a record of the legal home residence, outside of the facility, with the aim of having the person counted in the Census as a resident of their home address rather than at the prison address, passed Committee, not brought up for vote in House (HB1489, 99th General Assembly)

- Conducted Redistricting Bootcamp as legislative boundaries were redrawn based on the 2010 Census, working with the Lawndale Alliance, other community-based organizations and other elected officials
- Introduced a House Bill which provides that a person is not prohibited from photographing his or her own ballot at any time during the voting process, but a person who buys or sells their vote based on a photograph is guilty of a Class 4 felony (HB0431, 99th General Assembly)
- Introduced a House Resolution which designates September 22, 2015 as Voter Registration Day in Illinois (HR 694, 99th GA)
- Introduced legislation creating a mechanism to recall the mayor of the City of Chicago (HB4356, 99th General Assembly)

Ford has been the Chair of the Small Business Empowerment & Workforce Development Committee, Chair of the Foreclosure Subcommittee, and also the Chair of the Eighth District Education Oversight Subcommittee. Ford has had assignments in the Illinois House of Representatives Committees of Health Care Licenses; Tollway Oversight (Vice-Chairperson); Adoption Reform, Appropriations for Elementary and Secondary Education, Computer Technology, Disparities in Educational Achievement, Elections and Campaign Reform, Local Government, Pension Funds Management, Access to Federal Funding, Finance, Insurance, Juvenile Justice Reform, Revenue and Finance, Youth and Family, Health and Healthcare Disparities, Health Exchanges Subcommittee, Higher Education, Housing, Insurance, Tollway Oversight, Appropriations-General Service, Economic Development & Housing; Health Care Availability Access (Vice-Chairman); International Trade and Commerce; and Tourism and Conventions. Ford is also the Chair of the House Democratic Task Force to Increase State Government Business Opportunities for Minority-Owned Enterprises and Small Businesses, Chair of the Firearm Public Awareness Task Force, is a member of the Bipartisan Task Force to Promote Economic and Workforce Development, and is a member of the Illinois Violence Prevention Task Force.
